STUDY TRIP: Tallinn / Helsinki

- **Go out into the field to observe, analyse and broaden your vision.**

In partnership with Estonian Business School (the equivalent of HEC in France), the EMBA study trip takes place on the dual ESB campus in Tallinn/Estonia and Helsinki/Finland. Despite their geographical proximity, Baltic and Scandinavian countries are culturally very different from our students' home countries. Courses on the "all-digital" strategy intended to simplify the administrative life of citizens and companies, visits to companies specialised in the production and distribution of renewable energies using AI and IoT technologies, presentations on territory transformation projects (such as the TALSINKI project, led by Peter Vesterbacka) are just a few examples of the content of this immersive study trip that students have described as "a real opportunity for discovery".

FINDING FUNDING

There are several support options you can apply for, depending on your situation:

- Training course registered in the National Directory of Professional Qualifications (RNCP - level 1) - Code no. 29558
- Company skills development plan
- This course is eligible for CPF (Personal Training Account) funding
- OPCO training budget (for companies with 6 to 50 employees)
- PTP Transition Pro Bretagne system
- For job seekers: Individual Training Assistance (AIF) and Brittany region

GRANTS

Preferential rate applied if the programme is funded on a personal basis.
"Early Bird" discount for all applications submitted before September 1st.

You can deduct tuition fees and/or current expenses from income tax. Deduction of actual costs over the year of payment of training fees under "other deductible costs".

In addition to ongoing costs (transport, food), deduction possible on presentation of receipts from:

- professional training course fees (in your professional activity or as a job seeker)
- expenses incurred in acquiring a diploma.

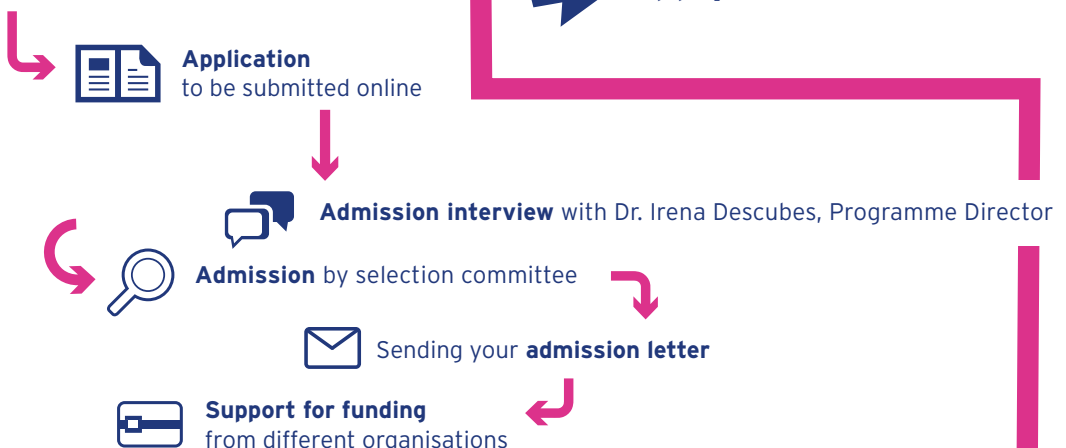
- Minimum of 5 years professional experience including 3 years in a general or functional management position.

DID YOU KNOW? STUDY SERENELY WITH eLIVE



Created by Rennes School of Business, the eLive system is used to teach courses to students, from home or in the classroom. With eLive, students attend classes in person in a dedicated and specially equipped room. Remotely, students not present in the classroom have direct access to the same classes and can therefore interact in the same way as students attending in person. The courses are also accessible to everyone via replay for 6 months.
